## Elk Island Catholic Schools 2020/21 Division Calendar

### **Background:**

Elk Island Catholic School Board (EICS) is tasked each year with approving a school calendar. The goal is to develop a calendar that meets the necessary hours of instruction, supports a quality learning environment and supports teacher and staff professional development. When creating the calendars, we consult with our neighbouring school divisions (Elk Island Public Schools (EIPS) and Battle River School Division (BRSD) in order to facilitate transportation schedules. During these consultations we create three calendars each year to support the differences between the EIPS and Battle River calendars and also the unique requirements for Our Lady of Mount Pleasant Catholic School's 4-day week.

### **Process:**

During the December 18th EICS Board of Trustees meeting, the Sherwood Park, Fort Saskatchewan-Vegreville calendar was presented and debated by the Board of Trustees. Next steps included seeking Board 'Approval In-Principal' of the calendar; they then will then be circulated to EICS Schools and School Councils for feedback during the month of January. The calendar will come back to the Board for 'Final Approval' during the February Board Meeting. The Camrose calendar will be presented at a later date.

### **Highlights**

- The fall break has been maintained and students start after Labour Day mirroring the EIPS Calendar.
- The proposed calendar does not have any added transportation costs.
- In developing the Divisional calendar, EICS Administration strives to create a calendar that meets required hours of instruction as well as supporting structuralized professional development and collaboration time for staff.

### School Division Insurance Update

The Division has received its 2019/20 school year final insurance invoices from our insurance provider Alberta School Boards' Reciprocal Insurance Exchange (ASBIE). The total invoiced insurance premium is \$1,139,007; this is an increase of \$748,121 over the 2018/19 school year. Some school boards have experienced increases of over \$1.0 million for their insurance premium.

#### **Options for the Division's insurance program:**

- Status quo with ASBIE (the hard market is projected to continue for another 18 to 24 months)
- Seek commercial insurance as an individual school board (lack of purchase power)
- Join Urban School Insurance Consortium (USIC requires new subscribers to pay upfront funds for the existing equity of the insurance pool)
- Unsubscribe from ASBIE and form new insurance reciprocal with other school boards

EICS is currently negotiating with a number of other school divisions across Alberta with similar positive claims histories to look at other insurance options. This list may continue to grow as school boards with good claim history consider join their effort to obtain market quote.

#### **EICS Board of Trustees Motion(s):**

That the EICS Board of Trustees directs administration to explore alternative market options for its insurance coverage.

That the EICS Board of Trustees serve notice to the Alberta School Board's Insurance Exchange (ASBIE) to terminate the Divisions participation in ASBIE in accordance with the subscriber agreement for the next school year.
