Governance Budget

The Board recognizes that Trustees are entitled to honorarium and compensation for expenses incurred in the performance of their duties. In addition, the Board believes that the Board's Governance budget must be set, monitored and publicly reported as are all Division budgets.

1. Budget

The Board Governance Budget and the Trustee Expense Schedule Appendix A will be reviewed and approved during the annual budget process subject to the following considerations.

- 1.1. The Budget will specify allocations for the Board Chair, Board Vice Chair, Trustees, membership fees and general Board expenses.
- 1.2. The budgets allocated to the Board Chair, Board Vice Chair and the Trustees will cover trustee honoraria, benefits, professional development and other expenses as indicated in Appendix A.
- 1.3. The budget allocation to membership fees will cover the following:
 - 1.3.1. ACSTA
 - 1.3.2. ASBA
 - 1.3.3. ASBA Zone 2/3
 - 1.3.4. Rural Caucus
 - 1.3.5. Alberta School Council Association
 - 1.3.6. Chamber of Commerce in Strathcona County, Fort Saskatchewan, Camrose and Vegreville.
- 1.4. The budget allocated to general Board expenses will cover the following:
 - 1.4.1. Board Public Relations (Advocacy)
 - 1.4.2. ASBA FGM/SGM Board Representative and one event per trustee
 - 1.4.3. ACSTA AGM for all Trustees
 - 1.4.4. Edwin Parr Award Night Representative

- 1.4.5. Annual Board Retreat
- 1.4.6. Board Directed Professional Development
- 1.4.7. Election Advertising Costs
- 1.4.8. General Board Expenses (meeting meals, snacks etc.)
- 1.4.9. Archbishop Dinner one trustee
- 1.4.10. Ukrainian Catholic Eparchy Bishop's Gala one trustee
- 1.4.11. Contracted Services (as required)
- 1.5. During the budget year, amendments to the specific allocations within the approved Board governance budget may be made after consideration and approval by the Board.

2. Honoraria

- 2.1. The basic honorarium and allowance generally covers all divisional governance activities related to school Board meetings and school related activities:
 - Public Board meetings.
 - Special Public Board meetings.
 - Meetings of Committees of the Board.
 - Meetings with Division staff and tours of facilities as planned by the Board.
 - Other Division meetings on behalf of the Board.
 - Optional attendance at concerts, plays and/or school functions.
 - Board sponsored events.
 - ACSTA/ASBA/CCSTA/CSBA meetings, conventions and workshops.
 - Other workshops, conventions, seminars and retreats.
 - Attendance at social functions of the staff.
 - Informal, unsolicited school or office visits and individual meetings with members of the staff or public.
 - Attendance at graduation exercises.

- Attendance at extra-curricular school activities.
- Attendance at meetings held by other organizations to which the Board appoints a representative.
- Any other related activities of the Board.
- 2.2. The honorarium shall be set on September 1 of each calendar year based on the following criteria:
 - 2.2.1. The basic honorarium of the Board of Trustees shall be calculated as follows:
 - 2.2.1.1. The average per Trustee honorarium shall be calculated from the previous Audited Financial Statements for all jurisdictions that are listed as Category 4 on Schedule 1 of the SUPERINTENDENT OF SCHOOLS REGULATION AR 94/2018.
 - 2.2.1.2. The Basic Honorarium shall be set at 95% of the median of the eight jurisdictions with the highest average honorarium, not including the average of Elk Island Catholic Schools.
 - 2.2.2. The Board Chair shall receive a Chair honorarium equal to 25% of the Basic Honorarium in addition to the Basic Honorarium.
 - 2.2.3. The Board Vice-Chair shall receive a Vice Chair honorarium equal to 10% of the Basic Honorarium in addition to the Basic Honorarium.

3. Individual Trustee Event Expenses

- 3.1. Funds for Trustee participation at conferences shall be budgeted for on an annual basis in accordance with Appendix A. The annual budget will account for registration fees, travel expenses, meal expenses and accommodation for Trustees to participate in Professional Development or Conferences. A Trustee may carry over a surplus or deficit to the next year. The expenses must be balanced by the end of the Board's four-year term.
- 3.2. The budget is set for each Trustee and Trustees must stay within their own professional development/conference budget.
- 3.3. If a Trustee wishes to pursue courses related to governance and Trusteeship, they may do so provided the reimbursement for course tuition fees falls within their budget for professional development.
- 3.4. A budget line has been set up to accommodate Board directed Trustee attendance at conferences that do not fall under the regular professional

development for a Trustee. Prior approval of the Board is required to qualify for a Board directed conference.

4. General Requirements

- 4.1. Annual honoraria shall be paid in accordance with Appendix A. Payment will be made in one twelfth (1/12th) installments by direct deposit. Honoraria will be processed in compliance with current tax regulations.
- 4.2. Trustees may claim eligible expenses for carrying out their roles and responsibilities in their capacity as Trustees of the Board, as per Appendix A.
- 4.3. The Secretary-Treasurer shall provide a monthly budget report to the Board and Superintendent as a means for Trustees to monitor choices for professional growth/conferences.
- 4.4. Spousal expenses will not be reimbursed by the Division Expenses paid by the Division for a spouse will be deducted from the Trustee's monthly remuneration.
- 4.5. Trustees may claim tuition fees for non-credit courses specifically relating to governance and trusteeship. Prior written approval of the Board Chair is required. The reimbursement of tuition must be claimed from the trustees Professional Development/Conference budget.
- 4.6. Trustees are required to stay within the approved budget for professional development/conferences. Special Board approval is required to exceed any individual trustees' professional development/conference budget.
- 4.7. The Board will review the Trustee Expense Schedule Appendix A annually.
- 4.8. Reimbursement and Approval of Board Expenditures:

To be reimbursed for expenditures:

- 4.8.1. Trustees will submit expenditures within 5 business days following the end of the month in which the expenditure was incurred.
- 4.8.2. Trustees are required to submit a signed Division expense claim form along with all receipts related to the expenditures being claimed for reimbursement.
- 4.8.3. Trustees are required to record the number of kilometers per trip when submitting a mileage claim on the Division expense claim form for reimbursement.

- 4.8.4. Receipts must be provided for all expenses that contain details regarding the good or service purchased, as well as itemized costs for each item with a total, which includes the GST, if applicable.
 - 4.8.4.1. In exceptional circumstances, a trustee may provide a written statement outlining why a receipt cannot be provided and it must be signed by the Board Chair or Board Vice-Chair.
- 4.8.5. The Board Chair will review and approve the Vice-Chair and Trustees expenditures.
- 4.8.6. The Vice-Chair will review and approve the Board Chair's expenditures.
- 4.8.7. Expense claims are forwarded to the Superintendent and or designate for review and processing.
- 4.8.8. Trustees will be informed by the Chair and Vice Chair of any alterations to a claim.

4.9. <u>Adjudication and Appeal</u>

- 4.9.1. Trustee disputes in the payment of a Division Expense Claim are to be made in writing to the Board Chair.
- 4.9.2. Appeals to the Board Chair ruling in 10.14.1 will be presented to the Board for resolution within the current school year.

TRUSTEE EXPENSE SCHEDULE

Mileage Reimbursement

\$0.58 per kilometer for the first 5000 km. and \$0.48 per kilometer over 5000 km.

The rate is set by the Canada Revenue Agency (CRA) and is reviewed on January 1 of each vear.

Mileage rates for reimbursement are based on rates outlined in the provincial government policy on Travel, Meal and Hospitality Expenses.

Trustees may claim mileage (kilometers) only for travel outside of their electoral ward.

Trustees from the wards Vegreville and Camrose traveling over 80 kilometers will receive a distance allowance of \$500 per year.

Meal Reimbursement

Expenses for meals shall exclude alcoholic beverages and shall be reimbursed by receipt Meals shall not be reimbursed if that meal type was provided for the conference or event that was attended.

Accommodation and Parking

Actual receipt.

Valet parking will not be approved unless alternative public parking was not available.

Per Diem Allowance

\$100.00 per partial day to a maximum of \$200.00 per day.

Per diems do not include regular Public Board and Committee meetings. Trustees are not to claim per diems unless there is loss of their primary source of income from regular employment as a result of conducting mandatory Board business.

Professional Development

\$3,000 \$3,500 per Board member allocated annually.

BACKGROUND:

<u>Education Act – Section 76</u>: Requires the following regarding the establishment of wards:

- The board may by bylaw provide for the nomination and election of trustees by wards and determine the boundaries of the wards.
- A board shall confirm (or amend if the board decided) the boundaries of its exiting wards or electoral subdivisions by December 31, 2024.
- If practical, provide that the number of trustees to be elected in each ward is in the same proportion to the total number of trustees of the board as the population to the total number of trustees of the board as the population of the ward is to the population of the school division.
- The board shall provide a copy of the bylaw to the Minister before December 31 in the year prior to an election year.



Board Policy 6: Establishes that the Board must pass any desired revision to the wards of the division by December 31 of the year prior to the year in which a general election is to be held. Policy 6 reads as follows:

Each of the following is established as a ward of the Division:

The Sherwood Park Catholic Separate School District No. 105

The Fort Saskatchewan Roman Catholic Separate School District No. 104.

The number of Trustees to be elected in each subdivision/ward is as follows:

Four (4) Trustees from the Sherwood Park electoral subdivision

One (1) Trustee from the Camrose electoral subdivision

One (1) Trustee from the Vegreville electoral subdivision

One (1) Trustee from the Fort Saskatchewan ward.

Bylaw 001-2020: The most recent bylaw to establish the wards and subdivisions of the division must be updated to reflect the ministerial order 008/2024. Refer to that ministerial order attached to see the inclusion of newly formed area in Ward 1 - Subdivision 3.

ELK ISLAND CATHOLIC SEPARATE SCHOOL DIVISION

BYLAW NO. 001-2020 -ELECTORAL BOUNDARIES

A BYLAW OF THE ELK ISLAND CATHOLIC SEPARATE SCHOOL DIVISION IN THE PROVINCE OF ALBERTA TO ESTABLISH ELECTORAL BOUNDARIES.

WHEREAS Section 76 of the *Education Act* provides that the board of a school division may by bylaw provide for the nomination and election of trustees by wards and determine the boundaries of the wards.

AND WHEREAS the Board of Trustees of Elk Island Catholic Separate School Division desires to establish the following wards within the Elk Island Catholic Separate School Division, pursuant to Ministerial Orders 058/2007, 064/2007, 075/2007, 080/2007, 004/2009, 036/2009, 068/2009, 072/2009, 056/2010, 063/2010, 068/2010, 002/2011, 010/2011, 015/2011, 055/2011, 002/2014, 019/2018, 011/2019 and 014/2020.

NOW THEREFORE the Board of Trustees of Elk Island Catholic Separate School Division enacts as follows:

The number of trustees to be elected shall be seven (7).

Elk Island Catholic Separate School Division will consist of the following wards:

WARD 1 SHERWOOD PARK shall consist of three electoral subdivisions and shall elect six (6) trustees as follows:

- Electoral Subdivision #1 shall elect four (4) trustees. The lands contained in Electoral Subdivision #1 lie within urban Sherwood Park, as well as lands outside the boundaries of the Hamlet of Sherwood Park within a portion of the municipal boundaries of Strathcona County, a portion within Leduc County and a portion within Beaver County.
- Electoral Subdivision #2 shall elect one (1) trustee. The lands contained in Electoral Subdivision #2 lie within the municipal boundaries of the City of Camrose as well as a portion of lands that fall within the municipal boundaries of Camrose County.
- Electoral Subdivision #3 shall elect one (1) trustee. The lands contained in Electoral Subdivision #3 lie within the municipal boundaries of the Town of Vegreville as well as a portion of lands that fall within the municipal boundaries of Beaver County, the County of Two Hills, the County of Minburn, Lamont County and the Village of Chipman.

WARD 2 FORT SASKATCHEWAN shall elect one (1) trustee. The lands contained in Ward 2 lie within the municipal boundaries of the City of Fort Saskatchewan and a portion in Lamont County, Strathcona County, Sturgeon County and the Town of Bruderheim.

A BYLAW OF THE ELK ISLAND CATHOLIC SEPARATE SCHOOL DIVISION IN THE PROVINCE OF ALBERTA TO ESTABLISH ELECTORAL BOUNDARIES.

WHEREAS Section 76 of the Education Act provides that the board of a school division may by bylaw provide for the nomination and election of trustees by wards and determine the boundaries of the wards.

AND WHEREAS the Board of Trustees of Elk Island Catholic Separate School Division desires to establish the following wards within the Elk Island Catholic Separate School Division, pursuant to Ministerial Orders 058/2007, 064/2007, 075/2007, 080/2007, 004/2009, 036/2009, 068/2009, 072/2009, 056/2010, 063/2010, 068/2010, 002/2011, 010/2011, 015/2011, 055/2011, 002/2014, 019/2018, 011/2019 014/2020 and 008/2024.

NOW THEREFORE the Board of Trustees of Elk Island Catholic Separate School Division enacts as follows:

The number of trustees to be elected shall be seven (7).

Elk Island Catholic Separate School Division will consist of the following wards:

WARD 1 SHERWOOD PARK shall consist of three electoral subdivisions and shall elect six (6) trustees as follows:

- Electoral Subdivision #1 shall elect four (4) trustees. The lands contained in Electoral Subdivision #1 lie within urban Sherwood Park, as well as lands outside the boundaries of the Hamlet of Sherwood Park within a portion of the municipal boundaries of Strathcona County, a portion within Leduc County and a portion within Beaver County.
- Electoral Subdivision #2 shall elect one (1) trustee. The lands contained in Electoral Subdivision #2 lie within the municipal boundaries of the City of Camrose as well as a portion of lands that fall within the municipal boundaries of Camrose County.
- Electoral Subdivision #3 shall elect one (1) trustee. The lands contained in Electoral Subdivision #3 lie within the municipal boundaries of the Town of Vegreville as well as a portion of lands that fall within the municipal boundaries of Beaver County, the County of Two Hills, the County of Minburn, Lamont County and the Village of Chipman.

WARD 2 FORT SASKATCHEWAN shall elect one (1) trustee. The lands contained in Ward 2 lie within the municipal boundaries of the City of Fort Saskatchewan and a portion in Lamont County, Strathcona County, Sturgeon County and the Town of Bruderheim.
